## Terms & Conditions - Jet2holidays Christmas Card Competition 2024

This competition is promoted by Jet2holidays Limited (registered number: 04472486) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2holidays", "we" or "us"). By entering the competition, you are deemed to accept these terms:

- 1. This competition opens at 12:00 on 12<sup>th</sup> November 2024 and closes at 12:00 on 24<sup>th</sup> November 2024.
- 2. Entrants to this competition must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays, Jet2.com Limited ("Jet2.com"), Jet2 plc or any companies within the same group or any organisation professionally involved with the competition (or in each case, their close relatives) are not eligible to enter. #### Choosing a Winner and Runners Up:

## The Prizes:
