

## **Terms & Conditions – myJet2 Perks Silver Cross Prize Draw**

This prize draw is promoted by Jet2.com Limited (registered number: 02739537) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2.com", "Jet2" "us" or "we").

The Prize will be provided by Silver Cross (UK) Limited whose registered office address is at Micklethorn, Broughton, Skipton, BD23 3JA (the "Prize Provider").

By entering this prize draw, you are deemed to accept these terms.

1. This prize draw opens at 09:00am (GMT) on 2<sup>nd</sup> January 2025 and closes at 11:59pm (GMT) on 16<sup>th</sup> January 2025.
2. Entrants to this prize draw must be:
  - (a) myJet2 members logged into myJet2 on the Jet2 app;
  - (b) residents of the UK, the Channel Islands or the Isle of Man; and
  - (c) aged 18 years or over.
3. 27. The Discount Code cannot be used (and will not apply):
  - (a) on any orders with a total order value of less than £150.
  - (b) against the purchase of Reef 2 Special Edition pushchairs and Reef 2 Special Edition bundles.

### General Terms:
